Dopis ANEM-a povodom predloga izmena Zakona o autorskom i srodnim pravima

Nakon odluke Vlade Srbije da bez javne rasprave usvoji Predlog Zakona o izmenama i dopunama Zakona o autorskom i srodnim pravima i uputi ga u skupštinski proceduru, ANEM je prvo reagovao saopštenjem od 23.11.2012, a zatim, 26.11.2012, upućivanjem dopisa svim poslaničkim grupama u Skupštini Srbije, Odboru za kulturu i informisanje, Odboru za obrazovanje, nauku, tehnološki razvoj i informaciono društvo, kao i nadležnom Ministarstvu prosvete, nauke i tehnološkog razvoja koje je pripremilo Predlog tog zakona. Saopštenja ANEM-a

ANEM je brojnim saopštenjima reagovao na različite izazove u medijskom sektoru i u ovom periodu:

Saopštenjem od 23.11., ANEM je protestovao povodom odluke Vlade Srbije da bez javne rasprave usvoji Predlog Zakona o izmenama i dopunama Zakona o autorskom i srodnim pravima i uputi ga u skupštinsku proceduru.

U zajedničkom saopštenju sa ostalim članovima medijske koalicije, od 8.11., ANEM je zahtevao od nadležnih što hitniju implementaciju Medijske strategije u delu koji se odnosi na projektno finansiranje medija i kontrolu državne pomoći, povodom novih slučajeva loše prakse dodelje budžetskih sredstava lokalnim medijima. Zajedničkim saopštenjem od 26.10.2012., Medijska koalicija je obavestila javnost o svom sastanku sa ministrom kulture i informisanja. ANEM je, u saopštenju od 1.12.2012., zajednički reagovao sa partnerima iz Medijske koalicije i povodom izjave predsednika opštine Bečeј, koji je najavio da će ova lokalna samouprava najverovatnije početkom sledeće godine osnovati sopstvene medije.

ANEM, NUNS, UNS i NDNV u svom zajedničkom saopštenju od 6.11. osudili su postupak kablovskog operatora SBB zbog toga što je isključio TV Avalu dok je ta televizija još emitovala program, a potom, suprotno svojim uslovima poslovanja, dodelio to mesto kanalu Pink 2.

U svom saopštenju od 5.11., ANEM je obavestio javnost zbog čega i kakve je predloge za izmenu radnog teksta Zakona o izmenama i dopunama Krivičnog zakonika uputio Ministarstvu pravde i državne uprave.

ANEM je svojim saopštenjima pružao podršku medijima i novinarima koji su u ovom periodu bili izloženi napadima i pritiscima. Saopštenjem od 19.10., protestovao je povodom diskriminacije novinara B92 kojima je bio zabranjen ulaz na javnu zajedničku sednicu opština sa severa Kosova. Saopštenjem od 31.10., ANEM je najošttrije osudio podmetanje eksplozivne naprave u dvorište kuće porodice novinarke B92. ANEM je saopštenjem reagovao i 27.11., nakon napada Ivana Jokovića, predsednika Skupštine grada Zaječara, na glavnu i odgovornu urednicu Best televizije iz Zaječara.

In the past two months, ANEM conducted a series of activities. We give you the highlights here:

ANEM round table and written suggestions on digitalization

On November 21, 2012, ANEM organized in Belgrade a round table entitled “Cooperation between different actors in addressing the challenges of the digitalization process”, which brought together all the important actors in this process. Following the event, On November 30, 2012, ANEM submitted its recommendations for the further implementation of the switchover to digital broadcasting of TV programs to all stakeholders in this process. Read the Recommendations [here](#).

ANEM activities directed to resolving the problem of illegal broadcasting of radio and TV program

As a continuation of activities addressing the fight against broadcasting “piracy”, on November 29, 2012, ANEM organized in Belgrade a round table entitled “Measures for effective prevention of illegal broadcasting of radio and TV program”, with over 40 relevant participants. ANEM comments on the draft version of Amendments to the Criminal Code

In its written Comments, submitted to the relevant Ministry on November 5, 2012, ANEM explained its remarks concerning the lack of decriminalization of defamation and insult and the deletion of Article 138 Paragraph 3 of the Criminal Code, which provided greater protection of journalists in the cases of threats due to their work. ANEM legal monitoring of the Serbian media scene

Monitoring Reports

In this period, two reports were published on ANEM website – [**Thirty-seventh Monitoring Report**](#) for September 2012 and the [**Thirty-eighth Monitoring Report for October 2012**](#) that was published in Serbian on November 30, 2012 (soon to be available in English as well). Both reports include expert analysis of the most important events on the media scene in Serbia in the periods they are referring to.

ANEM Monitoring Publication No. 7 coming soon!

Electronic Monitoring Publication No. 7 will soon be published on ANEM website, containing authors’ texts by Rodoljub Sasic, the Commissioner for Information of Public Importance and Personal Data Protection; Dragoljub Popovic, Judge at the European Court of Human Rights; lawyers Kruna Savovic and Slobodan Kremenjak, while the fifth text will be compiled of a brief overview of two judgments of the European Court of Human Rights relating to the application of Article 10 of the European Convention for the Protection of Human Rights and Fundamental Freedoms. Presentation of the print edition of ANEM Monitoring Publication No.7 will be held in December in Belgrade. More details about the Publication will be available soon, in the Monitoring Newsletter.

ANEM official letter regarding the Proposed Amendments to Law on Copyright and Related Rights

Following the decision of the Serbian Government to adopt, without a public debate, the Proposed Law on Amendments to the Law on Copyright and Related Rights and forward it to the Parliament, ANEM reacted first with the public statement on November 23, 2012 and then, on November 26, 2012, by sending an official letter to all parliamentary groups in the Serbian Parliament, Parliament's Culture and Information Committee, the Committee for Education, Science, Technological Development and Information Society, as well as the relevant Ministry of Education, Science and Technological Development, which had prepared the Proposed Law. As this Draft included, among other things, the switchover from analogue to digital broadcasting of TV program, ANEM took active part in the public consultations and submitted, on November 30, 2012, its written comments to the competent ministry. Read the Comments [here](#).

ANEM meeting with the Ministry of Trade and Telecommunications

On October 26, 2012, ANEM representatives held a meeting with the representatives of the Ministry of Foreign and Internal Trade and Telecommunications, which was also attended by representatives of eight ANEM TV stations. More about it [here](#).

On November 6, 2012, ANEM held a constructive meeting with the highest representatives of the Republic Broadcasting Agency (RBA), discussing a range of current issues important to broadcasters. Details about the meeting are [here](#).

ANEM series “Our Media”

ANEM, in cooperation with the production company A-media, completed a mini-radio and TV series “Our media”, depicting the situation of media in Serbia today. Five TV and five radio programs of this series were premiered during the last week of November on ANEM radio and TV stations across Serbia.

ANEM Statements

In this period, ANEM reacted to various challenges in the media sector in a number of statements:

In its [Statement](#) on November 23, ANEM protested against the decision of the Serbian Government to adopt, without a public debate, the Proposed Law on Amendments to the Law on Copyright and Related Rights and forward it to parliamentary procedure.

In its [Statement](#) on November 5, ANEM informed the public on its recommendations for amending the draft text of the Law on Amendments to Criminal Code, which ANEM had submitted to the Ministry of Justice and Public Administration.

In a [Joint Statement](#) with other members of the Media Coalition, on November 8, ANEM called the authorities on urgent implementation of the Media Strategy, particularly the part related to the project financing of the media and state aid control, on the occasion of new cases of bad practice of allocation of budget funds to local media. In a [Joint Statement](#) on October 26, the Media Coalition informed the public of its meeting with the Minister of Culture and Media. In the [Statement](#) on December 1, 2012, ANEM reacted, together with its partners from the Media Coalition, to the declaration of the President of Becej Municipality, who had announced that the local self-government was likely to establish its own municipal media early next year.

ANEM, NUNS, UNS and NDNV criticized, in their [Joint Statement](#) on November 6, the decision of the cable operator SBB to switch off TV Avala, despite the fact that this television was still broadcasting, and then substituted it, in absolute discord with its business practice, with Pink Channel 2.

ANEM provided support in its statements for the media and journalists who were subjected in this period to attacks and pressures. In the [Statement](#) on October 19, ANEM condemned the discrimination against B92 journalists, who were denied access to the public conference of municipalities in northern Kosovo. In the [Statement](#) on October 31, ANEM strongly condemned planting explosives in the courtyard of the B92 journalist's family home. On November 27, ANEM reacted with the [Statement](#) to the attack of Ivan Jokovic, president of the Zajecar City Assembly on the Editor-in-chief of Best TV from Zajecar.
