

## NOVEMBARSKI MONITORING IZVEŠTAJ br. 66 NA SAJTU ANEM-a!

### Kratak sadržaj:

- **Sloboda izražavanja** – analizirani slučajevi: ugrožavanje sigurnosti novinarke „Blica“ Milice Ivanović, nova „intervencija“ Komunalne policije prema novinarima, i bizaran slučaj „pritvaranja“ novinarske ekipe „Politike“ od strane privatnog lica; takođe je analiziran napad na ekonomsku forenzičarku i člana Saveta za borbu protiv korupcije Miroslavu Milenović, kao i otkazivanje promocije knjige „Vučić i cenzura“ u Nišu; stručno je komentarisan i Izveštaj Evropske komisije o napretku Srbije za 2015. godinu, u delu koji se odnosi na oblast medijskih sloboda. Sudski postupci – obrađena je presuda Višeg suda u Beogradu u sporu koji je vođen po tužbi Marijana Rističevića, poslanika SNS-a u Narodnoj skupštini, protiv RDP B92, za naknadu štete zbog povrede časti i ugleda.
- **Implementacija postojećih propisa** – Zakon o elektronskim medijima: pitanje političkog oglašavanje van predizborne kampanje i nastavak polemike povodom odluke Regulatornog tela za elektronske medije da ne pokrene postupak protiv televizija koje su direktno prenosile javni događaj SNS-a; postupak izbora kandidata za članove Saveta Regulatornog tela za elektronske medije. Zakon o javnim medijskim servisima: nove kontroverze oko finansiranja javnih medijskih servisa; postupak za izbor kandidata za članove Programskega saveta Javne medijske ustanove RTS.
- **Usvajanje novih zakona** – mogući problemi zbog najavljenog izostanka javne rasprave o izmenjenom Nacrtu zakona o autorskom i srodnim pravima.
- **Rad nadležnih organa** – Regulatorno telo za elektronske medije (REM)– pravna analiza Preporuke o vremenu emitovanja rijalitija „prisilnog okruženja“; Poverenik za informacije od javnog značaja i zaštitu podataka o ličnosti – analiziran je slučaj neovlašćenog objavljuvanja podataka o zdravstvenom stanju u medijima.
- **Proces privatizacije medija** – analiziran je slučaj „Tanjug“;
- **Zaključak Izveštaja** – sumirani nalazi i zaključak o situaciji na medijskoj sceni Srbije u novembru 2015.

## NOVEMBER MONITORING REPORT no. 66 ON ANEM'S WEBSITE!

### Short summary:

- **Freedom of expression** – the following cases were analyzed: the threats against the security of "Blic" reporter Milica Ivanovic, the new "intervention" of the communal police against reporters, as well as the bizarre case of detainment of the reporters of "Politika" by a private individual; the attack against the economic forensic expert and member of the Anti-Corruption Council Miroslava Milenovic, as well as the cancellation of the promotion of the book "Vucic and Censorship" in Nis; the Report also commented the European Commission Progress Report for Serbia for 2015, in the part concerning media freedoms. Legal proceedings - the Report analyzed the judgment of the Higher Court in Belgrade in the case of Marijan Risticevic, the SNS Member of Parliament, against RD B92, for damages due to injury to honor and reputation.
- **Implementation of existing regulations** – Law on Electronic Media: the issue of political advertising outside of the election campaign and the continued controversy over the decision of RBEM not to initiate proceedings against stations that broadcasted live a public event of the SNS; the procedure for the election of candidates for membership in the RBEM Council. The Law on Public Service Broadcasters: new controversies related to the financing of PSBs; the procedure for the election of candidates for membership in the Programming Council of the Public Media Institution RTS.
- **Adoption of new laws** – potential problems due to the announced lack of a public debate on the amended Draft Law.
- **Work of competent bodies** – The Regulatory Body for Electronic Media (RBEM) – the Report brings a legal analysis of the Recommendation about the Duration of "Forced environment" reality shows; Commissioner for Information of Public Interest and Personal Data Protection – the case of the unauthorized release of data on the health of private persons in the media.
- **Media privatization process** – the case of the Tanjug news agency
- **Conclusion of the Report** – findings summed up and the conclusion about the media situation in Serbia in November 2015.

The Sixty-sixth Monitoring Report was prepared by the ANEM expert monitoring team from the law office „Živković&Samardžić“, in cooperation with ANEM.
